

**O.A.D.G. Eddo Hoekstra Clinic April 17 and 18, 2010  
Rider Registration Form**

**Format and Schedule:** The clinic is open to riders who are members of the O.A.D.G. The format includes eight private lessons, approximately 45 minutes each, which will take place on each of Saturday and Sunday at Dewmont Farms, 228 Lowe Rd, Ashton Ontario K0A 1B0. Saturday and Sunday clinic hours are from 9:00 a.m. to 5:00 p.m. BBQ Lunch is included and served on site, Saturday and Sunday. Mr. Hoekstra will answer questions before lunch, during walk breaks and following each ride, time permitting. Eddo Hoekstra may request to ride your horse, in order to demonstrate a particular movement, etc. The clinic may be video-taped.

**Auditors:** The clinic will appeal to a broad spectrum of auditors, both specifically for dressage and also for sound training principles. Auditors will find this clinic to be particularly beneficial due to Mr. Hoekstra's considerable teaching skills and his engagement for the classical way of dressage.

**Rules:**

1. Riders must ride the horses listed on their registration, or if unavailable, must receive permission from the Clinic Secretary to substitute a horse. Riders wishing to substitute horses must complete an additional registration form, and must have a history of riding the horse.
2. For insurance purposes, riders and the horse owners must be members of their provincial equestrian sport organization (e.g. OEF or Quebec) and provide a photocopy of their 2009 or 2010 membership card(s). Photocopy of 2009 card MUST be followed with copy of 2010 card by Apr. 10, if your card is late.
3. Riders must wear an ASTM/SEI approved safety helmet at all times while mounted.
4. Turn-out: Riders are encouraged to braid their horse, so that Mr. Hoekstra can accurately see the neck position. Riders must be smartly turned out, with clean boots and attire fitted so that the rider position can be assessed.
5. Horses must arrive at the Clinic sound, fit and in good health. 2010 Coggins Test photocopy must be included with the registration (2009 Coggins Test results can be included with 2010 results to be sent by Apr. 1).
6. Contact Information: Please post your contact information on your horse's stall door, in case of emergency (i.e. cell phone number, vet emergency phone number, farrier phone number).

**Deadlines:** Completed registration form, including full payment must be received by the O.A.D.G. on or before the date of March 15, 2010; cheques dated not later than March 15, 2010. The O.A.D.G. is not responsible for late or misdirected mail. The O.A.D.G. will confirm receipt of your registration by email or phone. If you do not receive confirmation of receipt, please contact the Clinic Secretary before the deadline. The cheque from an alternative rider will not be deposited but shall be shredded (or returned to the rider at the clinic if preferred), unless the rider replaces one of the selected riders.

**Rider Fee:** \$160, longtime O.A.D.G. members (2009 & 2010 only, new members (2010) will pay \$200. First come – first served, cheque in hand!

The fee includes two private lessons, one on each day of the clinic and BBQ lunch each day. The clinic fee does not include stabling or rider accommodations. The full fee must accompany the registration. Cheques should be made payable to the O.A.D.G.

**Cancellations:** Riders who cancel for whatever reason will receive a refund less a \$25 processing fee, only in the event a replacement rider can be found by the O.A.D.G. If no replacement is available, the rider will not receive a refund. If the clinic itself is cancelled, all applicants shall receive a full refund.

**Stabling:** Take advantage of renting a stall to enjoy learning from the other rides, to maximize the benefit of Eddo Hoekstra's teaching. Limited box stall stabling is available starting Friday night at Dewmont Farms or a farm close by. **The stall rental fee is \$25 per night.** Riders must bring their own feed (grain, feed, hay and water pails). Riders/grooms are responsible for cleaning their own stalls. Initial bedding is provided, additional bags of shavings are available at a cost of \$5 per bag. No turnout available. The horses will be fed by stable management, night check is included.

**Hotels:** See separate listing on OADG web site.

**Selection Criteria for Qualifying Applicants:**

1. Riders must be paid up members of the O.A.D.G.
2. Selection will be "First come – First served" In case of a dispute the O.A.D.G Education Committee will make a selection.
